

FDC3 Agent Certification program

What is it: FINOS hosted formal badging program to certify product / platform implementations against the FDC3 Desktop Agent Standard.

Target audience: Fintech vendors hosting an app ecosystem, financial institutions (e.g. single dealer portals), any platform "running" FDC3 apps

Status: Approved by the Governing Board, free for 1 year since launch (at OSFF).

Call to action: Start <u>self-testing</u> (tests are OSS) and reach out to <u>rob.moffat@finos.org</u> to get certified around OSFF.

Cyber Resilience Act

The proposal for a regulation on cybersecurity requirements for products with digital elements, known as the Cyber Resilience Act, bolsters cybersecurity rules to ensure more secure hardware and software products.





What is Horizon Scanning?

Continuous subscriptions and data ingestion from prime identified regulatory agencies across operating geographies.

Enables extraction of multiple categories of data, such as notices, regulations, or news feeds, per user requirements.


Supports RSS feeds as well as custom data scanning formats.

Automated scheduled jobs continuously feed the latest data with no human intervention.

Data Science and analytics tools enable the automatic ingestion, analysis, and categorization of new and changing rules and regulations.

- An additional tool in the <u>FINOS Security tooling landscape</u>
- Enables
 - CVE scanning of dependencies, using <u>OWASP Dependency check</u> and similar tools
 - Static code analysis with <u>Semgrep</u>
- Easy to use and maintain run it local with one command
- Proactive (daily, scheduled) and reactive (on code changes) scans
- Git-based no need for external dashboards
- Consistent across 6 supported languages more will be supported soon
- Monitored by FINOS Staff
